3. The Hon. Norman Cafik, Minister of State for Multiculturalism was the only Canadian minister to go to Belgrade. His travel and other expenses associated with his attendance and paid out of the budget of the Department of External Affairs amounted to \$1,539.

4. Notifications of the attendance of senators and members of parliament were sent to the Canadian delegation as the names of those participating were made known to the Department of External Affairs. The delegation's instructions indicated that parliamentarians were to attend the meeting as "observers on the Canadian delegation".

MR. IAN HOWARD

2. Has Mr. Howard worked "overtime" since he joined the Minister and, if so, has he been remunerated, at what rate and what total amount as of March 1, 1978?

Hon. Iona Campagnolo (Minister of State (Fitness and Amateur Sport)): 1. Yes. (a) September 19, 1977. (b) Executive assistant. (c) On leave of absence from a position at the level of program manager 5. (d) (i) Salary range in previous position \$22,695 to \$25,473; (ii) Salary in present position not to exceed \$29,450.

2. Yes, with no remuneration.

3. \$2,568.22 since September 19, 1977. However, during the period of the assignment, Mr. Howard has received, in addition to this sum, \$2,480 to cover accommodation and \$1,402 in per diem allowances to compensate him for expenses incurred due to his absence from his home in Vancouver.

EXPENDITURES IN FRASER VALLEY EAST

Question No. 1,503-Mr. Patterson:

What amount was spent by the Department of Indian Affairs and Northern Development in the Constituency of Fraser Valley East in each year since 1970?

Hon. James Hugh Faulkner (Minister of Indian Affairs and Northern Development): 1977-78, \$3,054,990; 1976-77, \$3,045,226; 1975-76, \$2,190,270. Expenditures for previous years are not easily identifiable as departmental records are not maintained by constituency. The time required to provide this information would be considerable.

For the fiscal year (a) 1968-69 (b) 1977-78, what was the total amount paid by the government in family allowances?

Hon. Monique Bégin (Minister of National Health and Welfare): Family allowances paid in: (a) 1968-69 totalled \$56,186,052; and (b) 1977-78 totalled \$2,122,524,000 (subject to final adjustment). Please note the 1968-69 figures do not include expenditures under the Youth Allowances or Family Assistance Programs, both of which were incorporated into family allowances in the 1974 amendments. The amounts paid in 1968-69 under both programs were: Youth Allowances, \$52,457,272. Family Assistance, \$3,467,605.

Jones (Moncton): Mr. Speaker, on several occasions I have brought to the attention of this House and to the Parliamentary Secretary to the President of Privy Council (Mr. Pinard) that question No. 145, which was listed in this House on October 19, 1977, and had previously been on the order paper in July, 1977, has not as yet been answered.
