Is the Department of Energy, Mines and Resources paying \$142,656 to establish the prinicpal parameters governing the effectiveness of flocculants to remove particulate matter in coal washery effluents and provision of criteria for the preparation of superior flocculants for specific application and, if so, for what reason?
- 2. Will this study be in connection with an attempt to convert Cape Breton coal?

Mr. Dave Dingwall (Parliamentary Secretary to Minister of Energy, Mines and Resources): The Department of Energy, Mines and Resources reports as follows:

1. Yes, EM&R issued a contract for \$142,665.52 to Raylo Chemicals Ltd. of Edmonton, Alberta to establish the parameters governing the effectiveness of flocculants to remove particulates matter in coal washery effluents and provision of criteria for the preparation of superior flocculants for specific applications.

This scientific research and development contract is part of the continuing effort to support the Canadian coal industry by provision of environmentally acceptable techniques/materials for use in Canadian coal preparation plants.
