We are now prepared to begin the voting procedure.

Mr. Blenkarn: Mr. Speaker, I rise on a point of order. On September 16, 1986, I notified the Clerk of the House that I did not wish my name to be included on the list of those eligible as candidates. Unfortunately, the Clerk takes the position that I should have personally signed the letter of notification, which is not in accordance with the Standing Orders. The rules merely require notification, something which I undertook in writing. Therefore I ask that my name be removed from Part B of the Schedule.

Mr. Speaker: The Hon. Member will know that under the rules his name is properly on the ballot and that it cannot be taken off at this time. However, the House has heard the Hon. Member's views on this matter.

I would like to remind Hon. Members that the rules require them to print the first and last names of their candidate on the ballot before casting it.

I ask Hon. Members who wish to cast ballots to pursue the following procedure. Hon. Members will leave their desks through the curtains and come to the Table through the entrances on either side of me appropriate to the side of the House on which they sit. The Clerk Assistant will issue to each Member a ballot. Having cast their ballots I ask Hon. Members to please clear the voting area.

The voting will now begin.
