PENSIONS

INQUIRY WHETHER GOVERNMENT PREPARED TO INTRODUCE BILL TO INDEX PRIVATE PENSION PLANS UNDER FEDERAL JURISDICTION

Mr. Jean-Claude Malépart (Montreal—Sainte-Marie): Mr. Speaker, my question is directed to the Minister of National Health and Welfare.

The Minister is aware that the Government of Ontario has formed a task force to look into the possibility of indexing private pension plans that come under the province's jurisdiction.

Could the Minister inform the House whether he would be prepared to table, as soon as possible, a Bill that would be aimed at indexing private pension plans that come under federal jurisdiction, namely those in the areas of communications, interprovincial transport and financial institutions, to ensure that when employees who are now paying into a private pension plan are retired, they will not become any poorer because of inflation? Is the Minister prepared to follow Ontario's example?

Hon. Jake Epp (Minister of National Health and Welfare): Mr. Speaker, the Hon. Member will know about the difference of opinion on the indexing of pension plans within the Ontario Liberal Government. A number of cabinet Ministers have expressed different points of view publicly on it, as he is aware.

In respect of our Government, he should be reminded that we made a number of changes which improved the pension system, by not only changing the RRSPs, but also the RRIFs and the PBSAs.

INQUIRY WHETHER GOVERNMENT INTENDS TO UNDERTAKE COMPLETE REFORM

Mr. Jean-Claude Malépart (Montreal—Sainte-Marie): Mr. Speaker, the Minister is trying to recall the mini-pension reform he carried out. It was not a real pension reform to help people.

Does the Minister intend to proceed and introduce genuine pension reform, first of all, by correcting the unfair treatment of people who are single, separated or divorced and are not entitled to the spouse's allowance; second, by allowing for the indexation of private pension plans under federal jurisdiction; and third, by calling a meeting of the provincial governments to urge the province to index private pension plans as well?

Hon. Jake Epp (Minister of National Health and Welfare): Mr. Speaker, the Hon. Member does not know what he is speaking about. There have been major changes. I mentioned the RRIFs, the RRSPs, and the PBSAs. We have made changes to the Canada Pension Plan which are as dramatic as the introduction of the CPP in 1966. We also made changes to the spousal allowance.

If originally it was so wrong, why did they not make changes when they were still in government? We made changes. Now, after the changes have been made on the spousal allowance, they say it is discriminatory. If it is discriminatory now, what about when his Party was in office?
