Hon. Doug Lewis (Minister of State and Minister of State (Treasury Board)): Mr. Speaker, I wish to advise the House that when we return on September 13, the Government will be calling two Bills for consideration, Bill C-147, the Human Rights Institute followed by Bill C-152, the Canadian Heritage Languages Institute Bill. We hope, although I do not believe it is firm at this point, that there will be all-stage consideration of both Bills on that day.

On Wednesday, September 14, we will begin report stage consideration of Bill C-136, the Broadcasting Act.

My friend asked about the Elections Act. One knows that we presently have before us Bill C-79. There have been discussions and an exchange of correspondence with respect to election expenses. I understand that the matter of my friend's correspondence is still under consideration.

Mr. Angus: Mr. Speaker, just further to the comments from the Deputy House Leader, will the Government be in a position to respond with regard to the election expenses prior to the scheduled reconvening of the House on September 13?

Mr. Lewis: I will have to check into that, Mr. Speaker. My friend's letter had some suggestions in it. I think we want to consider those suggestions fully. In any event, we are looking at the whole matter. I think if we come back and have some time, it is certainly something that could be considered.
