When in opposition in 1982, in this House the Minister of Finance reproached then Minister of Finance Allan MacEachen for his attack on health and education spending. The Minister of Finance wept crocodile tears over the "risk of major cutbacks in medical care and post-secondary education"—to use his words, as a result of Mr. MacEachen's savage cuts to the provinces.

Now the Minister of Finance is making the biggest cut to social programs in the history of Canada. The effect of his cuts to health and post-secondary education in 1986 and 1989 will be to cut \$24 billion by 1994-95. The effect of the latest vicious cuts announced in the infamous budget of 1990 will cut an additional \$7.3 billion by 1995-96. The total of the cuts is the equivalent of all the federal money spent on health and education for two years running.

The Minister of Finance is the Pontius Pilate of medicare. By washing his hands of responsibility he is signalling to right wing governments across the country that they can slash medicare, hospital insurance and privatize universities with no threat of reprisals from the federal government.

The Minister of Finance has signalled his intention to pull the teeth from the Canada Health Act and refuse to enforce its provisions setting out minimal standards and hospital insurance. This government must be thrown out of office before they destroy—

MEECH LAKE ACCORD
