Mr. Gilles Duceppe (Laurier-Sainte-Marie): Mr. Speaker, I am concerned about the stand taken by the hon. member for Mount Royal who is in fact attacking the freedom of the press. That is how the member for Mount Royal sees national unity, Mr. Speaker.

Does national unity mean that the people of Quebec are to be made to believe that the NDP exists in Quebec because it exists in British Columbia? Come now! We know that would not be an objective statement and that is not the truth. So, once again, the CBC must reflect the reality and not be a propaganda tool at the hands of the government.

Must we, all in the name of national unity, display Chinese vases, would say a very contemptuous former prime minister as he did when he was having problems with Quebec?
