AWARDED FARM WITH **COSTS AND DAMAGES**

Judgment Given in Connection With Peculiar Case in Zorra.

WOODSTOCK, Dec. 17. — Judgment has been given by Judge Wallace in the case of Henry Pelton of this city vs. Catherine Legg of St. Marys, awarding the plaintiff the rightful ownership of the farm and damages to the extent of \$250 and costs. The particulars of the case are as follows: Miss Legg sold Pelton a farm in West Zorra for \$5,750. After the first payment had been made, friends of the defendant, who is over 80 years of age, prevailed on her not to accept the amount, as it was too low, and she refused to carry out the contract with Pelton. The latter then sued for the farm and damages for not being able to get on the ground this spring, thereby losing a crop.

EIGHT-HOUR DAY FOR BORDER POLICE

Chief Thompson Will Put New Schedule Into Effect Shortly.

WINDSOR, Dec. 17.—Declaring that eight hours daily is enough for anyone to work, and particularly police officers, if efficiency is expected, Chief Daniel Thompson, who assumed his duties here as head of the local department, declared today his intention of instituting an eight-hour day for members of the local force as soon as possible.

Two Windsor boys are held by the Detroit police, charged with obtaining money under false pretences. They are Earl McKee, aged 22, 145 Tecumseh road, and Louis O'Brien, aged 18, 466 Goyeau street. Clifford Curtis, 16 years oid, 740 Lycaste avenue, Detroit, is held on a similar charge.

According to Detectives Yank and Whitman, the Western Union Telegraph Company was muleted of about \$600 by means of forged telegraph money orders. Curtis, who is a telegraph company employee, is alleged to have sent out the code messages calling for payments of \$150 each. O'Brien and McKee, the two Windsor boys, it is stated, went to the cities upon which the fraudulent money orders were drawn and succeeded in collecting the cash.




