## EXTENSION OF RRAP ASSISTANCE—MOTION UNDER S.O. 43

**Mr. Stuart Leggatt (New Westminster):** Mr. Speaker, I rise on a matter of urgent and pressing necessity under Standing Order 43. In view of the fact that, despite repeated promises to assist transients and other low income individuals living in slum housing conditions in areas such as the downtown east side of Vancouver, and in view of the fact that the Minister of State for Urban Affairs (Mr. Ouellet) specifically promised legislation during the 1977-78 fiscal year now rapidly coming to a close, I move, seconded by the hon. member for Nickel Belt (Mr. Rodriguez):

That this House instruct the government to immediately introduce amendments to the National Housing Act, extending eligibility for assistance under the residential rehabilitation assistance program to the owners of hotels and rooming houses serving low income tenants, and that such assistance be available up to a ceiling amount of \$4,000 per room, with provision for forgiveness clauses in loans offered under the program.
