**THOMAS** Reg. No. C/639, ex-C/M Thottiparackal Thomas, 57, died October 14, 1991, at Orléans, Ontario. He was born April 19, 1934, at Mundiappally, India, and joined the Force as a civilian member May 1, 1969. He was employed at Headquarters, Ottawa, Ontario, until his retirement January 1, 1985.

**TURNER** Reg. No. 24075, ex-S/Sgt. James Arthur Turner, 45, died October 10, 1991, at Sault Ste. Marie, Ontario. He was born June 7, 1946, at Niagara Falls, Ontario, and joined the Force June 30, 1965, at Toronto. Upon completion of training at Depot Division, Regina, Saskatchewan, Turner was posted to "F" Division, Saskatchewan, and served at Regina, Fort Qu'Appelle and Estevan. On May 31, 1971, he was transferred to Headquarters, Ottawa, and posted to "A" Division, Ottawa, on January 2, 1973. On September 24, 1976, Turner was transferred to Headquarters again, and then posted to the Canadian Police College, Rockcliffe, Ontario. On July 1, 1986, Turner was transferred to Depot Division, where he served until his retirement October 1, 1991. He was promoted to corporal June 1, 1974; sergeant July 10, 1978, and staff sergeant July 27, 1987.

**WILMOTT** Reg. No. 12358, ex-Cpl. Dawson Millard Wilmott, 80, died November 14, 1991, at Nanaimo, British Columbia. He was born December 31, 1910, at Calgary, Alberta, and joined the Force June 2, 1934, at Edmonton. Upon completion of training at Depot Division, Regina, Saskatchewan, Wilmott was posted to "E" Division, British Columbia, serving at Vancouver and Dawson. On August 4, 1938, he returned briefly to Depot and was posted to

"K" Division, Alberta, working at Edmonton, Hardisty, Vegreville, Camrose and Stettler. On June 1, 1942, Wilmott took his discharge and reengaged on March 27, 1946, at Regina. He was posted to "F" Division, Saskatchewan, serving at Tisdale, Waskesiu, Smeaton, Wakaw and Prince Albert. On January 9, 1959, Wilmott was transferred to "E" Division, British Columbia, and worked at Nanaimo. He retired to pension September 1, 1960. Wilmott was promoted to corporal May 1, 1950.

**WOOD** Reg. No. O.628 (16821) Supt. John Taylor Wood (retired) 60, died December 30, 1991, at Ottawa, Ontario. He was born March 13, 1931, at Edmonton, Alberta, and joined the Force January 26, 1951, at Ottawa, Ontario. Upon completion of training at Depot Division, Regina, Saskatchewan, and "N" Division, Rockcliffe, Ontario, Wood was posted to "K" Division, Alberta, and served at Edmonton, Peace River, High Prairie, Slave Lake, Manning, Bonnyville, Lethbridge, Vulcan, Claresholm, Hinton and Calgary. On January 30, 1967, he was posted to Headquarters, Ottawa, and was later transferred to "B" Division, Newfoundland, working at St John's. On July 31, 1972, Wood was transferred to "H" Division, Nova Scotia, serving at Truro, and on August 4, 1975, he was transferred to "D" Division, Manitoba, working at Thompson. On July 15, 1978, he returned to Headquarters, where he served until his retirement May 6, 1988. Wood was promoted to corporal May 1, 1960; sergeant November 1, 1966; sub-inspector December 8, 1966; inspector December 8, 1968, and superintendent August 1, 1975. (Supt. Wood was the son of the late Commissioner S.T. Wood.)

**YOU** Reg. No. C/110, ex-C/M Shou Shan You, 75, died January 7, 1992, at Ottawa, Ontario. He was born April 28, 1916, at Yencheng, Kiangsu, China, and joined the Force as a civilian member on January 6, 1956, at Ottawa, Ontario. You was posted to Headquarters, Ottawa, where he served until his retirement June 10, 1981.
