To hereby authorize the Canadian wheat board to buy rapeseed and sunflower seed from producers at a price of six cents per pound for the best grade f.o.b. local shipping point and at appropriate prices for other grades during the period commencing on August 1, 1948, and ending on July 31, 1949; to sell rapeseed and sunflower seed so purchased or the oil extracted therefrom as directed by the Minister of Trade and Commerce; to enter into such contracts as the said minister may direct for the carrying out of any of these operations, \$1.
