**BRIDGES****PEACE RIVER—REQUEST FOR PROGRESS REPORT ON CONSTRUCTION**

On the orders of the day:

**Mr. W. C. Henderson (Cariboo):** I should like to ask a question of the Minister of National Defence. Could the minister give the house a progress report on the construction of the bridge which is being built across

the Peace river to replace the one destroyed in October, 1957? Can the minister say when the bridge will be open for traffic?

**Hon. G. R. Pearkes (Minister of National Defence):** I should like to thank the hon. member for having given me notice of this question. I am informed that a contract for the construction of the substructure and approaches for the new bridge was awarded on July 29, 1958 and this work was completed within schedule on April 15 of this year.

A further contract for the construction and erection of the superstructure was awarded on October 20, 1958 and the completion date for this work is November 15, 1959.

In answer to the hon. member's second question, it is expected that traffic should be moving freely across the new bridge by January, 1960.

**COMBINES INVESTIGATION ACT****GASOLINE—ALLEGED PRICE DISCRIMINATION IN SOUTHERN ONTARIO**

On the orders of the day:

**Mr. Frank Howard (Skeena):** I should like to direct a question to the Minister of Justice, notice of which was sent to him earlier. Has the minister received any requests for an inquiry under the Combines Investigation Act into the charge that price discrimination is being practised by certain oil companies during the present so-called gasoline war in southern Ontario and, if so, what action is contemplated?

**Hon. E. D. Fulton (Minister of Justice):** I thank the hon. member for having given me notice of this question. I find that a telegram dated April 21 has been received by the director of investigation, to which he has replied. I can advise the hon. member that in view of the request received from the Toronto area this matter is being carefully considered, and whatever facts the investigation discloses will be followed up in the usual way.
