EXTERNAL AFFAIRS

BIAFRA—BOMBING OF CIVILIANS AND RED CROSS OUTPOSTS

Mr. Andrew Brewin (Greenwood): Mr. Speaker, I wish to direct a question to the Prime Minister. Would the Prime Minister consider sending a special representative again to see General Gowon, this time to request him to take steps to have the consistent bombing of hospitals and other nonmilitary targets in the Biafra area stopped? [Mr. Pepin.]

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, I wish to direct a supplementary question to the Secretary of State for External Affairs. Because of the most recent bombings of Red Cross hospitals and headquarters in Biafra will the Canadian government now consider requesting a full scale investigation of these atrocities by some international agency such as the United Nations in order to alleviate conditions for civilians?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, if I thought any such action by the United Nations would be useful I would not hesitate, but I doubt if this could come before the United Nations, since it is an internal matter affecting the internal affairs of a member state of the United Nations, which would not agree to it being discussed.

Mr. Nystrom: As a supplementary question, would the Canadian government issue a formal protest to the Nigerian government deploring the most recent bombing of hospitals?

Mr. Sharp: I think it would be just as appropriate to make representations that the war should come to an end by the cessation of the resistance.
