what could be called a mandarin-industrial complex. These people on these boards come into close contact with the industrial leaders of this country. If there is a danger in respect of the military complex in the United States, I suggest the same thing could develop and is developing in this country.

Hon. members of the New Democratic party may suggest that President Eisenhower was referring to officers of the armed forces in the United States who are associated with big business in respect of procurement. The point I make is that there is too close an association between these large companies and government, and this is not necessarily in the interests of our private citizens. For that reason I should like to take this opportunity to warn the government about that sort of development. Certainly the government is not endangering anything it wishes to accomplish ultimately by accepting this amendment. The amendment does not restrict the government in the appointment of members from the public service to these boards of directors, if it feels it should do so.
