- 1. In 1968-69 and 1969-70, what were the estimated sums spent on research in the Department of the Secretary of State and what was the purpose of each research project?
- 2. How much money was actually expended according to Dominion Bureau of Statistics figures?
- Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council): I am informed by the Department of the Secretary of State and the Dominion Bureau of Statistics as follows: 1. Sums spent on research: 1968-69, \$43,211; 1969-70, \$301,891.
