# TREFANN COURT URBAN RENEWAL, TORONTO—SCOPE OF GRANT FOR SECOND PHASE

Hon. Paul Hellyer (Trinity): I have a supplementary question, Mr. Speaker. Does the announcement of a \$2.1 million grant toward the second phase of the Trefann Court urban renewal eliminate the rehabilitation of existing housing as alleged, and did the approval include all or any part of the financing applied for by Trefann Court Homes Corporation?

Hon. Ron Basford (Minister of State for Urban Affairs): Mr. Speaker, the answer to the latter part of the question is no. The Trefann Court Homes Corporation application for, I think it is some 16 units of housing, is a separate application, and approval of phase two has relation to urban renewal.

Mr. Speaker: Order, please. I would bring to the attention of hon. members that we have gone beyond the time allocated for questions. I had hoped to recognize two or three more questioners before moving to orders of the day, but if hon. members have many supplementaries I will have to call orders of the day.

Mr. Hellyer: Mr. Speaker, my supplementary question is really part of my previous supplementary which I think the minister overlooked. I asked whether or not the terms of the phase two renewal program really make adequate provision for rehabilitation of existing housing or whether in fact the proposal put forward by the government eliminates that possibility, as has been alleged in Toronto?

Mr. Basford: Mr. Speaker, phase two which has been approved does so. There are discussions with the province of Ontario now under way as to the application of the newly approved neighbourhood improvement proposals in respect of the Trefann Court area, so that the rehabilitation sections, by which grants and loans of up to \$5,000 can be made, would apply in the Trefann Court area under the newly passed legislation. It is that course I hope will be pursued. I will be meeting with the Trefann Court people this evening, I believe, to discuss the possible application of these provisions to that area.

APPROPRIATION BY UNITED STATES OF FUNDS FOR PAVING HAINES-HAINES JUNCTION LINK AND ALASKA HIGHWAY TO TERMINATION IN CANADA

Mr. Erik Nielsen (Yukon): Mr. Speaker, I have a question for the Minister of Indian Affairs and Northern Development. I would ask whether he is aware of any legislation which has been passed by the Senate of the United States to appropriate some \$58 million for paving of the road link between Haines in the State of Alaska and Haines Junction in Canada and on up from Haines Junction to the termination of the Alaska highway in Canada? If he does have such knowledge, will he tell the House whether the Canadian government is now negotiating or intends to negotiate with the government of the United States in respect of the expenditure of these funds on the construction to be undertaken on these highways?
