Due to the extremely short deadline imposed by the United Nations there was insufficient time actively to request participation of non-federal government organizations in the preparation of the paper but a number of unsolicited submissions by interested groups were taken into account. The matter of further consultations on this subject is under consideration.

6. Yes. The Government will make the Canadian "country statement" available to members of Parliament by tabling.

Question No. 1,668—**Mr. Stewart (Okanagan-Kootenay):**

1. How many veterans of the Boer War are there in Canada?

2. How many veterans of the Boer War are receiving veterans pensions?

3. What is the average pension received by a veteran of the Boer War?

**Hon. Daniel J. MacDonald (Minister of Veterans Affairs):** 1, 2 and 3. Estimates of the veteran population and record of pensions in payment do not separately identify veterans of the Boer War. These data are included in World War I figures provided to answer to Question No. 1,670.

VETERANS AFFAIRS—NUMBER OF KOREAN CAMPAIGN VETERANS AND PENSIONERS

Question No. 1,669—**Mr. Stewart (Okanagan-Kootenay):**

1. How many veterans of the Korean War are there in Canada?

2. How many veterans of the Korean War are receiving veterans pensions?

3. What is the average pension received by a veteran of the Korean War?

**Hon. Daniel J. MacDonald (Minister of Veterans Affairs):** 1. Based on information obtained from the 1961 Census and adjusted for mortality by the Canadian Life tables, 1960-62, the estimated number at June 1, 1973 will be 26,000.

2. Two thousand and forty-three as at December 31, 1972.

3. Two thousand and forty-three Korean Campaign veterans as at December 31, 1972, were receiving a total amount of \$2,272,008. Their average annual pension as at the date was \$1,112.09.

Question No. 1,670—**Mr. Stewart (Okanagan-Kootenay):**

1. How many veterans of the First World War are there in Canada?

2. How many veterans of the First World War are receiving veterans pensions?

3. What is the average pension received by a veteran of the First World War?

**Hon. Daniel J. MacDonald (Minister of Veterans Affairs):** In the records maintained by the Department of Veterans Affairs, information with reference to veterans of World War I includes the veterans of the Boer War. Consequently the answers to Parts 1, 2 and 3 of this question incorporate the information requested in Question No. 1,668. 1. Based on information obtained from the 1961 Census and adjusted for mortality by the Canadian Life Tables, 1960-62, the estimated number at June 1, 1973 will be 81,000.

2. Eighteen thousand nine hundred and thirty-five as at December 31, 1972.

3. Eighteen thousand nine hundred and thirty-five World War I veterans, as at December 31, 1972, were receiving a total amount of \$28,537,125. Their average annual pension as at that date was \$1,507.11.

**Hon. Daniel J. MacDonald (Minister of Veterans Affairs):** 1. Based on information obtained from the 1961 Census and adjusted for mortality by the Canadian Life Tables, 1960-62, the estimated number at June 1, 1973 will be 769,000.

2. One hundred thousand five hundred and four as at December 31, 1972.

3. One hundred thousand five hundred and four World War II veterans, as at December 31, 1972, were receiving a total amount of \$126,511,500. Their average annual pension as at that date was \$1,258.77.
