*The accounts earn interest quarterly at a rate determined as if the excess of receipts over disbursements each quarter since the accounts were established had been invested in Government of Canada 20-year bonds. In effect, the quarterly rate is based on the weighted average yield of all investments over the previous 20-year period.

Some interest earnings in excess of the rate used in the most recent actuarial reports on the accounts (6.5 per cent per annum) have not been credited to the accounts, but rather have been used to offset the cost of amortizing actuarial deficiencies that arise mainly as a result of annual salary increases. These amounts are as follows for 1984-85:
