CHILD CARE

REQUEST FOR BUDGETARY MEASURE

Ms. Margaret Mitchell (Vancouver East): Mr. Speaker, my question is directed to the Prime Minister who stated at the First Ministers' Conference that his commitment to a child care program is real and he is prepared to allocate substantial resources to this initiative. I commend him for that. In view of the urgent child care crisis right across Canada, will the Prime Minister allocate in the next Budget an emergency federal fund for child care services?

Right Hon. Brian Mulroney (Prime Minister): Indeed, Mr. Speaker, the commitment of the Government to child care is real and substantial. We have worked very closely with the provinces. The Minister of National Health and Welfare will be convening, I think in early January, a meeting of the appropriate Ministers to deal specifically with this issue.

It must be dealt with, as my hon. friend knows, jointly with the provinces, and the federal Government will be providing both leadership and resources to bring this about.

Ms. Mitchell: Mr. Speaker, we have a national case of child neglect in Canada. We need action now. It could take years to complete those negotiations.

REQUEST FOR \$320 MILLION

Ms. Margaret Mitchell (Vancouver East): Will the federal Government do what Katie Cooke advocated and allocate \$320 million in the upcoming Budget and begin to deal with this emergency during the period when negotiations are going on with the provinces? We need to upgrade and extend child care services in the meantime.

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, my hon. friend is quite right when reference is made to the fact that this very important matter of child care has been neglected by the federal Government for years. That is an accurate statement.

Ms. Mitchell: What are you going to do about it?

Mr. Mulroney: My hon. friend will not have to wait for years to have this matter resolved.

Ms. Mitchell: This Budget?

Mr. Mulroney: It is a priority for this Government and I hope for this House.

Ms. Mitchell: This Budget?
