4. Bill respecting drainage on and across the property of railway companies, (Mr. Casey); Ordered; Presented, 25. Read a second time; Referred to a select committee, 94. First Report of committee, recommending employment of a short-hand writer; Concurred in, 134.
5. Bill further to secure the safety of railway employees and passengers, (Mr. Casey); Ordered; Presented, 25. Read a second time; Committed; Progress reported, 94, 161, 181, 202. House again in Committee; Bill amended, 202. Order for consideration discharged; Bill recommitted; Amended; Motion for consideration; Amendment moved by Mr. Casey to recommit the Bill, 218. Negatived, 219. Amendments considered; Bill read a third time and passed, 220.

9. Bill to amend the Railway Act with respect to the shipment of grain, (Mr. Richardson); Ordered, 43. Presented, 44.
10. Bill further to amend the Railway Act, (Mr. Blair); Ordered; Presented, 242. Read a second time; Committed; Reported, 254. Passed, 261. By the Senate, with amendments, 345. Considered, 357. Agreed to, 358. R. A., 434. (61 Vic., c. 22.)
11. Motion by Mr. Jameson, that the railways of Canada should be brought under the control of a Board of Railway Commissioners; Debate thereon adjourned, 85.
