FREE COPIES OF "HANSARD"

Question No. 614—**Mr. Caouette:**

Does the government intend to grant the request of every citizen who wishes to receive regularly a free copy (one per family) of the official report of the House of Commons *Hansard*, and (a) if not, for what reason (b) if so, when will the government do so?

Hon. Judy V. LaMarsh (Secretary of State): Under existing government regulations, authorized by TB 477983, dated April 6, 1955, and amended by TB 477983-1, dated May 6, 1955, no provision is made for the free distribution of government publications, including *Hansard*, to every Canadian family. These regulations do specify, however, that such material is provided free to a variety of institutions across the country, including all public libraries at which they are available to the general public.

Furthermore, pursuant to an Order of the House of Commons, dated May 28, 1948, each Member of Parliament may have as many as 16 copies of *Hansard* sent free of charge to residents of his constituency.

Above this free distribution, any citizen who so desires may subscribe to *Hansard* at an annual cost of \$3.

The government is not at the present time giving consideration to possible changes in these regulations. Amendments such as suggested by the hon. member for Ville-neuve could involve an additional cost to the public treasury of as much as \$10 million per year.

DEMURRAGE ON BOX CARS, WEST COAST

2. How much grain was on track waiting to be unloaded during the strike at the Vancouver ports which took place from June 2 to August 13, 1965?

3. Were the railway companies given remuneration or concessions of any kind for box cars loaded with grain waiting to be unloaded at the west coast ports from June 2 to August 13, 1965 and, if so, how much?
