Railways were not in a position to say definitely whether they could handle the transportation of this wheat to Churchill?

Mr. Sharp: Mr. Speaker, a discussion has been going on between the wheat board and the railway companies on this important point, and neither side has satisfied the other yet.

Mr. Simpson: On a question of privilege, Mr. Speaker, it seems to me that we have a definite conflict of answers coming from the treasury benches. I refer Your Honour to Hansard of Thursday last, October 13, and an answer given by the Minister of Transport who stated, among other things, that this year there are box cars available—

Mr. Speaker: Order, please. I suggest to the hon. member that it is not a question of privilege when there is a discrepancy between statements made either by two members of the government or two other members of the House of Commons. This is a point of debate which the hon. member may wish to raise in other circumstances, but it is not a question of privilege.

Mr. Simpson: Then through you, Mr. Speaker, could I ask the two ministers to get together and give us an answer?

Mr. Speaker: The Chair will use its good offices to achieve this.

FINANCE

INQUIRY AS TO PRESENTATION OF ADDITIONAL BUDGET
