OTHER UNIVERSITIES—RELATIONS

In view of the fears of a backlash developing against foreign students in Canada as a result of the events at Sir George Williams University, will the minister make a statement outlining his discussions of Monday in this regard with Clarence Bayne of Sir George Williams University?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, on Monday I received a delegation of students, professors and others who were interested in the Sir George Williams affair. I had originally intended to give them half an hour, but decided they needed a couple of hours to express their views. I did so because I was deeply concerned about any possible repercussions there might be in respect of our relations with the British West Indies. I am sure members of the house would consider it most unfortunate if these events should have any unhappy consequences with respect to the very good relations we now enjoy with the British West Indies.
