Questions

Mr. D. R. Tolmie (Parliamentary Secretary to Minister of Consumer and Corporate Affairs): Mr. Speaker, in view of the lengthy answer, I wonder if hon. members will agree to have it recorded in *Hansard*.

Mr. Speaker: Is this agreed?

Some hon. Members: Agreed.

[Editor's note: The abovementioned answer reads as follows:]

- 1. The Department of Consumer and Corporate Affairs has taken action under the Hazardous Products Act with respect to clothing flammability as follows: (a) Effective November 2, 1971, it became an offence to sell any consumer article of any kind containing a dangerously flammable textile. A burning test procedure is used to classify textiles of this category. Briefly, a 3.5 second burning time limit has been established for a 5-inch length of material under prescribed test conditions. (b) Effective November 2, 1971, a more severe regulation was established for children's nightwear. In this instance the burning time using the same test procedure is set at a minimum of seven seconds.
- 2. Statistical information on the number of burn cases and their degrees attributable to specific causes such as textiles is not available in Canada at present. Accident statistics have in large measure been medically oriented. In order to make most effective use of the Hazardous Products Act, information on events leading to injuries is required along with details of offending agents. To correct this situation the Department has in recent months initiated discussions with provincial authorities and hospitals for the purpose of setting up a reporting system which will permit acquisition of such information.
- 3. For reasons stated in the reply to part 2 of the question, it has not been possible to obtain this information.
- 4. In addition to the regulations with respect to clothing listed under Part I of this question, regulations have been issued under the Hazardous Products Act which establish flammability limits for bedding and toys. Work is in progress to develop flammability regulations for a wider range of clothing, carpets and mattresses, and to continue study of the use of fire retardant treatment of textiles.

SCIENCE COUNCIL OF CANADA—DUTIES OF MR. HUNKA Question No. 103—Mr. Fortin:

- 1. What are the duties of Mr. Hunka of the Science Council of Canada?
 - 2. What is his salary?
- 3. Is he bilingual?

Hon. Alastair Gillespie (Minister of State for Science and Technology): In so far as the Science Council is concerned, our replies are as follows: 1. Chief of Administration.

2. In the range \$18,400-\$22,100 per annum.

- 4. None. On the contrary, he has paid special heed to the government's policy on bilingualism and has, in large part, been responsible for the fact that the Science Council has a higher than average percentage of bilingual persons on its staff.
- 5. As there are no equivalent positions on the staff of the Science Council, this question is considered as 'not applicable'.

FUNDS FOR DRUG ABUSE CAMPAIGN AND ANTI-SMOKING CAMPAIGN

Question No. 342-Mr. Rynard:

- 1. Was the drug abuse campaign fund reduced for the fiscal year 1972-73 and, if so, for what reason?
- 2. Were the Department of National Health and Welfare antismoking program funds doubled for the fiscal year 1972-73 and, if so, for what reason?
- 3. What was the breakdown in spending for (a) the drug abuse program (b) the anti-smoking campaign for the fiscal year 1971.72?
- Hon. John C. Munro (Minister of National Health and Welfare): 1. No. Funds for 1971/72 totalled \$4,843,000. (This includes \$520,000 Summer Students Projects). Funds approved for the Non-Medical Use of Drugs Directorate for 1972/73 total \$5,330,000. (This includes \$632,000 Summer Students Projects).
- 2. Yes. Funds for 1971/72 totalled \$173,000. Funds approved for 1972/73 total \$386,000. This increase of more than 100 per cent will allow for expanded research and education activities.
 - 3. Final expenditures are not yet available for 1971/72.
