INTENTION RESPECTING MODERATION OF RATE OF INCREASE IN EXPENDITURES IN VIEW OF RATE OF INFLATION

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I have a question for the Prime Minister relating to the continued high rate of inflation in the country and the fact that the estimates of federal government spending tabled for the current year are some 40 per cent higher than the corresponding estimates of federal spending tabled only two years ago. I should like to ask the Prime Minister whether he has any firm intention of moderating the rate of increase in the expenditures of his government as part of a fight against domesticallyinduced inflation?

**Right Hon. P. E. Trudeau (Prime Minister):** Yes, Mr. Speaker. We shall certainly do our best, particularly in the area of bringing to an end programs which have run their time, and we hope we can count on the support of the opposition parties in bringing such programs to an end.

#### Some hon. Members: Oh, oh!

**Mr. Stanfield:** Is it the position of the government, and particularly of the Prime Minister, that the growth in the estimated expenditures of the government, amounting to 40 per cent over a near two-year period, is appropriate in light of the current inflationary pressures in the country?

**Mr. Trudeau:** When we are talking of global figures it is good to remember the individual programs which form part of those increasing expenditures, and once again I call
