POSSIBILITY OF LIMITATION ON CHEESE IMPORTS—
GOVERNMENT POSITION

Mr. John Wise (Elgin): Mr. Speaker, my question is directed to the Minister of Industry, Trade and Commerce. It relates to Canada's import quota on cheese. In light of the indication which the Minister of Agriculture made at the Agriculture Outlook Conference yesterday that he would not allow foreign cheese imports to harm Canadian cheese production, is the Minister of Industry, Trade and Commerce in a position today or will he be in a position in the near future to make an announcement on this very important and pressing matter?

Hon. Donald C. Jamieson (Minister of Industry, Trade and Commerce): Mr. Speaker, I am not able to give an actual date because, as the hon. member will know, the discussions are quite complex and are still going on, merely interdepartmentally but in terms of the GATT provision and related international questions. I can assure the hon. member it is being given urgent consideration at the present time. An announcement will be made as quickly as possible with regard to the quota for 1976.

Mr. Wise: Mr. Speaker, may I ask the minister whether he supports the tightening of a quota on foreign cheese imports which is apparently supported by the Minister of Agriculture?

Mr. Jamieson: Mr. Speaker, my views on the matter will become known at the time the quota is announced.
