BILINGUALISM—ROYAL MILITARY COLLEGE

Question No. 2,161—Mr. Cossitt:

1. On what date was the decision made that the Royal Military College, Kingston, Ontario, is to become a bilingual institution (a) was this decision made by Cabinet (b) what are the names and job designations of all persons recommending or taking part in arriving at such decisions (c) what are the reasons for the government not following the recommendation of the Royal Commission on Bilingualism and Biculturalism that RMC should remain an English language institution?

2. (a) What is the full nature of the entire estimated or budgeted cost of making RMC bilingual (b) a description and cost of all new capital construction (c) the number of additions to the staff and total salaries involved?

Hon. James Richardson (Minister of National Defence): 1. September 14, 1972. (a) No, it was made by the Treasury Board. (b) The Defence Management Committee composed of senior officials of the department made the recommendation to the Minister of National Defence who approved it and submitted it to the Treasury Board. (c) The decision to introduce the programme of instruction in both official languages at RMC was taken to meet a requirement for training of future professional officers in keeping with the government policy on bilingualism.

2. (a), (b), (c). The estimated cost of the program to make RMC institutionally bilingual is as follows: (1) Capital construction to improve teaching facilities for the whole college and to provide the additional classroom, laboratory and office space necessitated by the requirement to provide academic programmes in both languages—\$5,990,300. (2) Up to 84 additional civilian staff members and some 23 military personnel will be employed gradually over the next three years, as the program is implemented. The salaries of such personnel, once the
