General Insurance Company of Canada

They have demonstrated leadership in many areas, including safety at sea, modernization of ships, care and attention for crews, and care for the men who have served on ships. They have served actively and meaningfully not only at sea but also on shore.

We can do no better in this chamber than to accommodate the requirements of the Canadian Merchant Service Guild and give speedy passage to the bill now before us.

Hon. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, as the sponsor of the bill has pointed out, my colleague, the hon. member for Comox-Powell River (Mr. Skelly), represented us on the committee which dealt with the bill. On his behalf I am happy to indicate our readiness to support it on third reading. I do so not only on his behalf, but in recognition of the fact that, although I was not here 60 years ago when the first charter was granted, I did have contacts with the Canadian Merchant Service Guild in the 1940s and 1950s. I know of the good work this organization has done, and I agree with my colleagues who have spoken that this guild deserves to have its charter updated. Mr. Speaker, we are happy to give third reading to this bill.

Motion agreed to, bill read the third time and passed.

The Acting Speaker (Mr. Blaker): Earlier the House indicated its intention to consider and pass all stages of Bill S-18 this afternoon. We will proceed in that fashion.

Mr. Dennis Dawson (Parliamentary Secretary to Minister of Employment and Immigration) moved the first reading of Bill S-18, to amend and repeal an act to incorporate General Security Insurance Company of Canada.

Mr. Dawson moved the third reading of the bill.
