

(b) Eighty-five of the 121 recommendations accepted have been implemented through policy.

(c) The remaining acceptable recommendations will be implemented following enactment of Bill C-69.

(d) Fourteen recommendations were rejected:

COMP 24	Implementation would result in duplicate investigations and an unnecessary inconvenience to witnesses.
COMP 25	Judged to be impractical.
DIS 3	The familiar expressions of counselling, cautionings and warnings are to be retained.
DIS 7(1)	Judged to lack significant meaning and application.
DIS 9, 10, 11	Considered inappropriate in personnel administration.
DIS 13	Members will be required to answer questions relating to the matter under investigation if the member is alleged to have contravened the Code of Conduct. Answers given will not be admissible in any criminal proceeding or disciplinary hearing except to prove a false statement.
DIS 23	Not applicable—tribunal is one officer.
GRIEV 2	Considered inappropriate in personnel administration.
GRIEV 7	Redundant—by reason of provision in GRIEV 4, which has been implemented through policy and is proposed for Bill C-69, Sub-Section 31(5).
GRIEV 10	If a grievor chooses another member for assistance, then no cost attaches. If he chooses counsel, then it will be at his cost.
GRIEV 18	Division Staff Relations Representatives (DSRR) are elected by the membership of the Force, and the presence of the DSRR on all Boards will ensure that the interests of the grievor are always protected.
GRIEV 30	The present DSRR system is felt by the RCMP to be a suitable vehicle for bringing collective concerns to the attention of the Commissioner.
