Mr. Albert Cooper (Parliamentary Secretary to Minister of State and Leader of the Government in the House of Commons): I am informed by the Privy Council Office and the Treasury Board of Canada as follows:

Following the February 26, 1991 budget, the number of public service senior managers as of January 31, 1991, is being reduced by 10 per cent (from 4750 to 4275), with the bulk of the reduction to be achieved within one year and the remainder by March 31, 1993. In the period January 31 to November 30, 1991, the management category population decreased by 231, or 48 per cent of the reduction target of 475.

What is the anticipated cost of the National Transportation Act review panel appointed by the Minister of Transport to review federal transportation economic regulatory legislation?
