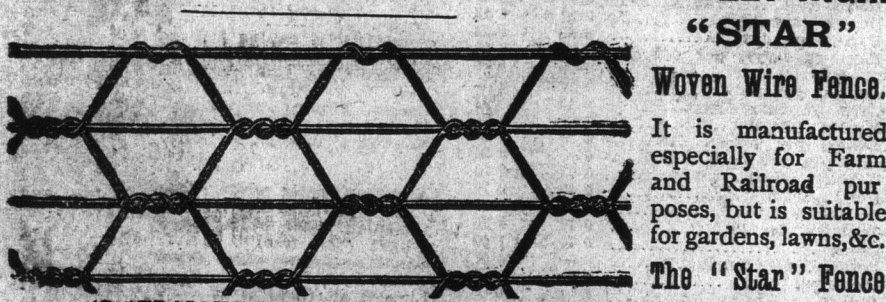

## OTTAWA.

OTTAWA, Jan. 2.—General Gascoigne informed me tonight that he had not heard a word of any proposal to send a Canadian regiment to China. He regarded the cable report as a newspaper canard.

The Ontario elections are to take place next month. Dissolution occurs immediately at the close of the present session, about the middle of the month.

The Roman Catholic hierarchy will meet at Montreal to consider the pope's encyclical on the school question. The mandement will be read in all the churches next Sunday.

OTTAWA, Jan. 3.—Instructions have been issued to city postmasters not to send to the dead letter office any letters for postage. The empire which may be mailed short of postage under Hon. Mr. Mulock's three cent per ounce proposal of a few weeks ago. Possibly some people may not have heard of the cancellation of the postmaster general's proposal. For the present short paid letters will be sent forward to their destination, the postmasters affixing the necessary stamps to make up the deficiency in postage.

A representative of the Sun called at the post office inspector's office yesterday and enquired about these instructions. The officers in charge stated that they had certain private instructions, but they did not feel at liberty to give them to the press. The postmaster was visited and was also disposed to be reticent in the matter.

### MR. KING WINS.

Judge McCleod delivered judgment on Monday morning in the case of Sloan v. King. He briefly reviewed the evidence of the plaintiff, saying that if the gift and the loan were proved there would be a legal liability. But when the plaintiff's statement it appeared to be incomplete in that while she set up that the letters in evidence were replies to letters sent by her requesting the repayment of the \$5,000, yet it did not appear from the former that there had ever been any demand of that sum. In fact, the letters enclosing the money appeared to be just what they pur-

ported to be, gifts from time to time. The theory of the payment of interest was likewise unsupported. On the other hand, Mr. King explained the circumstances connected with the \$17,000. It was drawn about two years before the time mentioned by the plaintiff. Of this sum the defendant proved \$12,000 was given in \$1,000 to Sweeney, to pay the men and \$5,000 forwarded by express, also that he never had such a sum in the plaintiff's house. Taking all the evidence together, his honor felt that he could do nothing else than decide that the defendant never gave the plaintiff \$5,000; that plaintiff never loaned defendant \$5,000; that no interest had been paid and that defendant did not owe plaintiff anything. He, therefore, ordered that a verdict be entered for the defendant.

A. W. Macrae for plaintiff asked for a stay of postea, with all rights reserved to plaintiff. This was granted. Pugsley, C. C., A. W. Macrae and J. A. Sinclair appeared for plaintiff; Curry, Q. C., and A. W. Baird for defendant.

### HE LOST BOTH CASES.

In the city court Thursday Daniel Hatfield, a man about forty-five years of age, was the plaintiff in two civil suits of a novel character.

Mr. Hatfield's first suit was against a Mrs. Seymour, an elderly widow. The particulars stated that the claim was for \$5 per cent on her husband, B. P. Raymond, who defended the suit, objected to these particulars, but said he would prefer trying the case out. When the plaintiff took the stand it was shown that the alleged loan was made about fourteen years ago to Mrs. Seymour's husband, who has since died. He lived for several years after the loan, but Mr. Hatfield had never collected the sum, and now wanted it from the widow. Mr. Hatfield at this point informed the court that he had been an invalid for eight years, and all the doctors he had tried them all could do him no good, but some African medicine had put him on his feet again.

Mr. Hatfield's second suit was against James Clark. This proved rather more formidable than the other. Mr. Clark is a son-in-law of Mrs. Seymour. Long years ago, some time before the big fire of 1877, Mr. Hatfield was paying attention to Mrs. Seymour's daughter, who is now Mrs. Clark. He says he gave her a ring (he wasn't quite sure whether or not it was an engagement ring) and a gold watch. She accepted these articles, he said, and afterwards married Clark. Since his recent recovery by the virtue of the new remedy, he had started up to clear up his affairs, and he now brought suit for \$20, the value of the watch, and \$5 for the ring, which he had bestowed on Miss Seymour. He admitted the ring only cost \$4, but after so many years he thought it was a reasonable charge for the use of it. Mrs. Clark admitted receiving the articles, but said both were gifts and so long a time had elapsed she did not know what became of them. Needless to say, the plaintiff lost both cases.

## WAR IN THE AIR.

British Regiments Ordered for Service in India at Once.

It is Reported that an English Ship Has Fired on a Russian Man of War.

LONDON, Dec. 30.—The Daily Graphic asserts "on authority" that the British squadron was definitely instructed to assemble off Chempulpo to support a strong British expedition with Corea on the dismissal of McLeavy Brown, British superintendent of Corea customs, who under the advice of the British consul has twice returned the notice of dismissal served upon him.

With regard to Fort Arthur, the Daily Graphic asserts there is every reason to believe the Russians will adhere to their pledge to evacuate at the end of the winter, and there is the sector of England. After the part of the government regard the occupation of Kiao Chau as calling for action, because British interests are not threatened. According to the Daily Graphic both the foreign offices and the admiralty are agreed upon this point.

NEW YORK, Dec. 30.—According to recent estimates the reserve forces of the British navy number 28,000 men. Of this number it is calculated that least ten thousand would be required in case of war, to complete the manning of the warships of Great Britain, which are understood to require a complement of 110,000 men, whereas only 100,000 men are said to be actually in service. The naval reserve problem has long been discussed by British authorities, and the general opinion appears to be that the number of men available is far short of the number which would be required in case of war.

In addition to the men of the naval reserve, Great Britain has a large reserve fleet and a number of reserve merchant ships, including the Capitanis, Lucania, Umbria, Maesic, Teutonic, Empress of India, Empress of China, Empress of Japan, Himalaya, Australia, Victoria and Acadia.

LONDON, Dec. 31.—The Daily Mail has received telegrams from Hong Kong and Tientsin denying the French occupation of the island of Hai Nan, but it regards it as morally certain that Hai Nan was occupied about a fortnight ago, when Port Arthur was occupied by the Russians, the colonel of Saigon, the Ernest Simon, layed French Cochinchina, including the French mail boat Ernest Simon. Before the latter left Saigon on the 25th, a French cruiser arrived there with either Admiral Bedolliere or letters from him to the French governor of Saigon. The Ernest Simon layed for an hour at Saigon, and the governor's despatch relating to the hoisting of the flag on the island of Hai Nan to the French governor.

"The cause of the delay was known only to a few of the officials on board the Ernest Simon, but inadvertently French Cochinchina, including the French mail boat Ernest Simon, before the latter left Saigon on the 25th, a French cruiser arrived there with either Admiral Bedolliere or letters from him to the French governor of Saigon. LONDON, Dec. 31.—A letter from Kobe says: "Military manoeuvres of great magnitude were executed in Japan last month for the first time since the war with China."

LONDON, Dec. 31.—A despatch to the Daily Mail from Shanghai, dated yesterday (Thursday), says: "A British fleet of eight ships and four torpedo boats has arrived at Chempulpo. There are two Japanese cruisers in the Yang-Tse-Kiang river. Japan is working night and day preparing for war. It is believed that the British and Japanese fleets are in close touch."

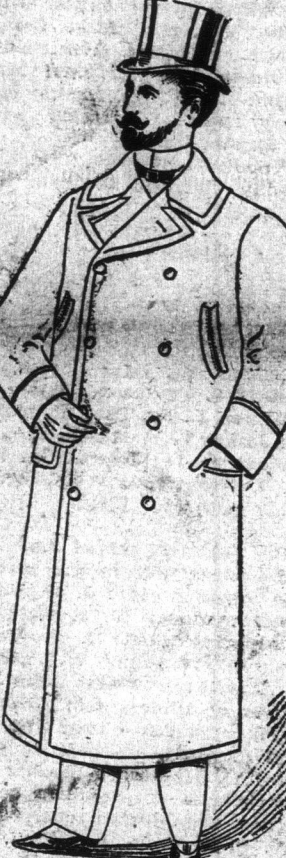
LONDON, Dec. 31.—A special despatch from Shanghai says that communications are constantly passing between the British and Japanese of ficers, and it is understood that the Japanese ministers are trying to effect a rapprochement with England on the basis of a joint guarantee of reform in Chinese administration.

LONDON, Jan. 1.—According to a special despatch from Shanghai, a sudden stiffening has taken place in the attitude of the Tsung Li Yamen toward Germany, resulting in a demand for the evacuation of Kiao Chau, and leading to the belief that Great Britain is bringing the pressure to bear upon Pekin.

A despatch from St. Petersburg says that on Thursday, Emperor Nicholas granted an audience to the Chinese minister, Yang Yu, who handed the Emperor a personal letter from the Emperor of China. It is reported there that the conversation turned on the proposed Chinese loan.

being too small for the free movement of the Russian vessels.

LONDON, Jan. 2.—A sensation has been caused by a rumor from Plymouth that the English admiral has fired on a Russian man-of-war in Chinese waters. Nothing is known as to the matter at the foreign office or the admiralty.

The morning papers publish also a statement that England is pressing China to declare Port Arthur a free port. It is supposed that the presence of British warships there is intended to insure freedom of access for trading vessels.

LONDON, Jan. 2.—A despatch from Malta says that a battalion of the Seaforth Highlanders has been ordered to Egypt.

CAIRO, Jan. 2.—A battalion of the Cameron Highlanders has been ordered to be in readiness to ascend the Nile at a moment's notice.

CALCUTTA, Jan. 2.—It is reported from Kurram that the Afridis are assembling in tribal council with a view of concluding peace. White Gen. Hammond was examining the enemy's caves near Lund Kot after the recent fighting shots were fired at the group of officers standing with him. Gen. Hammond's orderly officer was severely wounded.

LONDON, Jan. 3.—The Daily Graphic claims to have authority for the assertion that no agreement exists between Russia and Germany with regard to China. That Germany occupied Kiao Chau without Russia's cognation, and that the occupation annoyed the advisors of the czar.

LONDON, Jan. 2.—A despatch to the Times from Pekin dated Friday says: "The arrangements with Russia for the guarantee loan are actively proceeding, and when completed the Russians on the plea of supervising the collection of the land tax, will obtain the right to enter every Yamen in the empire."

LONDON, Jan. 3.—The Cairo correspondent of the Daily Mail says as part explanation of the British advance upon the Nile that it is believed French expeditions have arrived quite close to Khartoum. According to the same authority the British force will be commanded by Major Gen. Sir Francis Grenfell.
