A Big Price.

Some of Japan's Conditions of Peace With China.

The Japs Make Two Successful Attacks on Their Antagonists.

A Snow Storm in Italy Results in Serious Loss of Life.

Disastrous Storms.

NAPLES, Jan. 11.—A violent wind and snow storm swept over Foggia, on the great plain of Puglia, today. Six houses collapsed. Eight persons were killed and many others injured.

The Baring Liquidation Concluded.

LONDON, Jan. 11.—The Baring liquidation has been formally and finally concluded. A circular was issued tonight thanking the guarantors and relieving them from all further liability.

The Gale in Great Britain.

QUEENSTOWN, Jan. 11.—So severe was the gale here today that the Cunard Line steamer *Ethiopia* was unable to stop and was obliged to proceed direct to Liverpool, carrying mails and passengers for this port. The wind is southeast, blowing violently off the coast.

Death of Composer Godard.

PARIS, Jan. 11.—Godard, the composer, died at Cannes today, after a lingering illness. Benjamin Louis Paul Godard was born in Paris in 1849, and began work in the conservatory at the age of 14. He wrote the opera "Les Bijoux de Jeannette," "Pedro de Zalamea" and "Jocelyn."

No One to Blame.

LONDON, Jan. 11.—The inquiry into the circumstances concerning the collision on the London and North Eastern Railway at Chelford on Dec. 22, in which 15 persons were killed and about 30 wounded, was finished today. The jury found that nobody was criminally negligent.

Trouble in Corea.

LONDON, Jan. 11.—The Korean court is in great distress and wants money, even in such small sums as 500 yen, which cannot be got together without the greatest difficulty. The Tong Haks are gaining influence by degrees and are at present being met with throughout the whole extent of Corea. They are causing the greatest ravages in the north of Seoul up to Ping Yang.

Japan's Terms.

LONDON, Jan. 11.—The Standard's Berlin correspondent telegraphs: I learn from a good quarter that Japan's conditions of peace, beside demanding an indemnity, will provide that Corea be independent of China and under Japanese suzerainty; that China cede certain islands, raise the fort at Taku, dismantle Port Arthur and Wei Hai Wei and demolish all fortifications on the route from Corea into China, and that Japan fix the future number and type of Chinese warships. The establishment of relations looking to a China-Japanese alliance will be required.

Peculiar Parisian Sweetmeats.

PARIS, Jan. 11.—Visiting cards to those that you never think of on another day, kisses on each cheek to those that you do meet, and sugar plums galore, with or without other gifts, are distinguishing marks of the Parisian's New Year. The sweetmeats take every conceivable form. In the windows there are monkeys and baboons in chocolate, cats, dogs, pigs and doll millinery in tinted cream; sugar lilies, roses and orchids; even cabbages, carrots, turnips, onions and asparagus incredibly natural and all of which when their crisp outer crusts are bitten into will send down the surprised throat streams of cordial. Even men, relatives and friends, exchange satin bags of chocolate or caramels.

The Japs' Latest Success.

LONDON, Jan. 11.—A dispatch dated Kaiping, Jan. 10, midnight, says that Gen. Negi, who commanded the Japanese troops which took part in the battle near that place, reports, "Over 200 Chinese are known to have been killed, but it is impossible to ascertain the number of their wounded. We took 150 prisoners."

Japanese reports that 1,600 Chinese troops under Gen. Sui were moving up to support Kaiping, but learning the result of the engagement there, are now retiring upon Yang Kow.

A telegram from Shanghai says: The Japanese army occupied Kaiping on Jan. 10. Gen. Sung and the other Chinese officers and soldiers made a precipitate retreat to Yanking, and the latter town is now in great confusion. The foreigners at Kaiping have made their escape to Chin Chow.

BERLIN, Jan. 11.—The Cologne Gazette advises the Government of Japan to make peace with China at once. It will be a dangerous thing for Japan, the Gazette says, if her desire for the fruits of victory increases, as her demands might become so exaggerated that the European powers could not allow China to concede them.

The army, under Major-General Osoko, came into collision with the enemy at a place between Ke Ga Sai and Ka Mah and Ka Kah Ga. The enemy fell back on Yung Kiu and to the west. According to a report by sea, there are 20,000 of the enemy and two cannon at Lin Yang, and 17,000 between Hai Ching and Lio Yang.

The number of the Chinese routed by the third division is over 10,000 men. Later advices say the number of Chinese casualties in this fight are about 200 killed and wounded. The five battalions of the third division and 50 field guns took part in the action.

Churchill's Relapse.

LONDON, Jan. 12.—Lord Randolph Churchill was suddenly seized last night with an attack of heart weakness which threw him into a state of coma. He rallied this morning and is now conscious but is weak.

Being Driven to the Wall.

LONDON, Jan. 12.—A dispatch from Tien Tsin says the Japanese are steadily advancing upon Chin Chow and the Chinese are slowly retreating to the great wall, where they intend to make a stand. The progress of both is impeded by the heavy snow.

THE MIDDLEMARCH MURDER.

Welter's Cognizance of Hendershott's Insurance.

The Dead Man's Fiance in the Witness Box.

ST. THOMAS, Jan. 11.—Evidence that Wm. Welter was aware of the fact that there was \$11,000 of insurance on the life of Wm. Hendershott, the victim of the Middlemarch murder, and that he knew that the beneficiary under the policies was his fellow-prisoner, John Hendershott, was adduced at the investigation yesterday.

TESTIMONY OF MISS WELTER.
Today the evidence of Miss Welter, the young lady to whom the murdered man was engaged, was taken. She detailed a conversation which took place between the prisoner Welter and herself while driving to this city shortly after the murder, but nothing of importance was elicited. She knew that the deceased had \$11,000 insurance on his life, but did not know who was the beneficiary.

OTHER WITNESSES.
Edwin Frost swore that he met the Hendershotts driving towards the city at 11:30 on the morning of the tragedy. Dr. Lawrence, who made the post mortem examination; read his report, showing a total of nineteen wounds and scars on the head and body and that they might have been caused by an axe or similar instrument. Drs. Gustin and Smith gave corroborative evidence. Dr. Duncombe, for the defense, said if the ground were soft the deceased's head might have been under the tree and not have been crushed, but said the wounds might have been caused by an axe.

The court resumes tomorrow at 9:30.

SCREAMS FROM THE EAGLE

At the Idea of Great Britain Hiring an Island.

NEW YORK, Jan. 11.—The leading editorial in today's Sun is a scorching criticism of President Cleveland's recommendation that Necker Island be permitted to be leased to a British cable company. The Sun advocates the annexation of Hawaii and then, it says, a British corporation can be safely permitted to land a cable upon Necker Island.

CRANFORD, O., Jan. 11.—The Leader today has an editorial entitled "Keep the British Out of Hawaii," and goes on to say: All along the Welland Canal there are forts which could be put in position for defense at short notice. There are powerful British naval stations on the Atlantic and Pacific in connection with the military stations. There is a military and naval station in the British West Indies, and British ships can easily patrol the entire Atlantic coast. British ships prowl about the Gulf of Mexico, and the British nose is poked into everything that is done in the interest of the people of the United States. If Great Britain were given a foothold in the Hawaiian Islands now, as the President suggests, there would soon be an attempt to follow up that advantage by a wholesale gobble of one or more of the islands.

BURNED OUT.

TORONTO, Jan. 11.—Losses by last night's fire will amount to \$750,000, with insurance half that amount.

NEW YORK, Jan. 11.—The furniture store of Jordan & Moriarty, on Park Row, was destroyed by fire this morning. Loss, \$20,000.

LONG ISLAND CITY, Jan. 11.—Tonight fire destroyed the express and baggage houses, the annex ferry house and sheds, and the express record office of the Long Island Road Company. Loss, \$50,000.

POLITICAL NOTES.

Mr. Joseph King has been definitely chosen as Mr. Conmee's opponent in West Algoma.

The Reform nominating convention for East York will be held in Boston's Hall, Little York, on the afternoon of the 17th inst.

A Liberal convention will be held at Cayuga on Saturday, Jan. 19, for the purpose of nominating candidates for the Legislative Assembly for the county of Haldimand.

At the York county Conservative convention on Friday the only nominees whose names went to ballot were Mr. McLean and Mr. Henry Duncan. The result of the vote was McLean 192, Duncan 50.

D'Alton McCarthy addressed a large audience at Barrie Friday night.

Mr. John Fox, president of the North Middlesex Conservative Association, has called a meeting of that body for Jan. 29 to select a candidate for the Commons.

Gone to the Happy Hunting Ground.
HALIFAX, Jan. 11.—James Paul, chief of the Micmac Indians, of Nova Scotia, died on Thursday on the Indian reservation of St. John's, in the 96th year of his age, being born Jan. 5, 1800, at Rocky Lake. He was installed as chief by the late Archbishop Walsh 35 years ago, succeeding Francis Paul, and had since then been recognized in that capacity.

Carrying Coal Across Lake Erie.
ERIE, Pa., Jan. 11.—Col. S. B. Dick and General Manager T. Blair returned today from Montreal, where they completed a traffic arrangement with the Grand Trunk in co-operation with the Port Stanley and Lake Erie Railroad and the Conneaut, Port Dover and ferry system. The arrangement includes coal from the P. S. and L. E. Road and general merchandise to and from Canada by that route, including points south.

A Gananque Woman To Be Tried for Bigamy.

Prince Albert is getting cool weather—46° below zero.

Hon. Mr. Taillon, Premier of Quebec, is reported much better.

Mr. Fleming has instructed his solicitors to ask for a recount of the votes in the Toronto mayoralty contest.

The recount in the Toronto mayoralty election will commence Monday next at 9 o'clock before Judge Macdougall.

The man who died in the Imperial Hotel at Niagara Falls on Tuesday has been identified as Wm. Stults, of Greenville, Pa. His daughter will take his remains home.

Mrs. James Dempster, who was arrested at Gananque on a charge of bigamy, was brought before the Brockville police magistrate for a preliminary hearing on Friday, and was committed for trial.

Inspector Wattam, formerly of the Northwest Mounted Police, died at Kingston asylum on Tuesday. He was present at the battle of Cat Koff during the Northwest rebellion, and was an old British soldier.

The Province of Quebec used to reap \$12,000 yearly from licenses on peddlers. The bill imposing a tax of \$100 on peddlers, which came before the Legislature this session, is deferred till next year at the request of an influential deputation.

It is now feared by the Winnipeg police that A. M. Dillon, the missing newspaper hawker, has been murdered for his money. He had a large amount with him when he so mysteriously disappeared a week ago. His affairs are in satisfactory shape.

Michael J. Power, died on Friday in Halifax, in the 62nd year of his age. He had been a member of the Local Legislature from 1882 to 1894, and Speaker of the Assembly for the past eight years. He was universally respected and a popular politician.

A BABY PRISONER.

A One-Year-Old Girl Sent to Prison—Charged With Disorderly Conduct.

TRINITY, Jan. 12.—Police Justice Courtier has committed Mamie Ford, a one-year-old baby, to the county jail as a disorderly person. The child belonged to Katie Ford, who lived in a notorious part of the town, and was committed to the jail for disorderly conduct. The warden refused to receive the child because it was not named in the commitment, so the police justice made out a new commitment for the one-year-old, and designated its crime as disorderly conduct. This commitment brought about a controversy. The warden still refused to receive the baby because he knew it had not been disorderly.

The county solicitor and the presiding judge were appealed to. Judge Woodruff asked the police justice in what way the child had been disorderly. "It cried in court yesterday when the mother was on trial," Judge Woodruff advised the warden, for humanity's sake, to allow the child to remain with its mother, because it was sickly and not likely to live.

REPUDIATED BY THE C. O. F.

A. E. Stephenson and H. Rosenbaugh Are Not in It.

BRANTFORD, Ont., Jan. 11.—A paragraph with the heading "Foresters Arrested" has been going the rounds of the papers, setting forth that one A. E. Stephenson, an ex-supreme chief ranger of the Illinois Foresters, and H. Rosenbaugh, of the Canadian Order, were arrested. As a matter of fact, these parties have no connection with the Canadian Order of Foresters. The head office of the Canadian Order of Foresters is located in the city of Brantford, and said order does not transact any business in the United States—its business is confined to the Dominion of Canada only.

WORK AND WAGES.

Large Reductions in the C. P. R. Working Force.

TORONTO JUNCTION, Jan. 11.—Large reductions have been made in the staff of the Canadian Pacific employees here. The bridge and tunneling department suffered the most, and nearly all the hands were laid off. The men along the line who keep the roadbed in repair have also been reduced, and each section is reduced to two men. Those who were fortunate enough to be on are only working a few hours each day. A small reduction was made in the traffic department.

WINNIPEG, Jan. 11.—Following up the economy line, the C. P. R. will reduce the number of trains per week on the Manitoba branch lines.

BROOKLYN, N. Y., Jan.—To the surprise of the motormen and conductors on the trolley lines of this city, a strike was ordered this morning.

AFTER THE FIRE.

Insurance Rates in Toronto May Be Increased Twenty-Five to Fifty Per Cent.

TORONTO, Jan. 11.—The 40 fire insurance companies that are represented in Toronto had representatives at a meeting of the Underwriters' Association today. A resolution was submitted that the rates of insurance be increased by 50 per cent on all buildings over four stories high, and by 25 per cent on all others. The meeting was in favor of adopting the idea, but it was finally decided to hold the resolution in abeyance, pending the action of the city regarding the purchase of steam engines and other equipment.

TORONTO, Jan. 11.—Spectators at the ruins of the recent Globe fire yesterday afternoon witnessed one of the most thrilling sights imaginable, when a falling wall 60 feet high carried Eli A. Bowber down with it into the debris. The man is alive, and there are good hopes of his recovery. No bones were broken.

Mrs. Owen, who jumped from the Oranby building at the fire last night, is better, and fatal results are not anticipated.

All Drowned.

NIAGARA, Jan. 11.—Three American soldiers from Fort Niagara were drowned on Thursday evening. The unfortunate men left the fort intending to cross the river to Niagara on the Lake, and when within about 200 yards of the shore the boat became fast in the moving ice. After drifting for some time a tremendous wave struck the boat, upsetting it. The poor fellows succeeded in climbing on the bottom of the boat, calling piteously for help to the throngs of spectators who lined the beach, unable to do anything to assist them. After clinging to the boat for an hour the soldiers were by one dropped off. Their names are unknown.

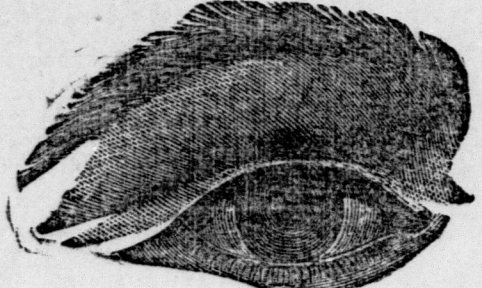
Dun's Weekly Review.

New York, Jan. 11.—R. G. Dun & Co.'s weekly review of trade says: Neither the beginning of the new year nor the failure of the Currency Bill has brought any material change to business as yet. The Currency Bill with its possibilities of vicious amendments was a source of apprehension to some, but with that out of the way the deficiency of the treasury receipts remains, and the exports of gold do not cease.

Exchange through the principal clearing houses are 25 per cent larger than last year, but 24 per cent less than 1893. There has not been much time for change in the industries, but the differences observed since the new year began are not in the direction of higher prices or larger demand. There are more indications of late that the stocks of different kinds of goods have been accumulating in consequence of the past increase in production. The failures for the week have been 420 in the United States against 474 last year, and 54 in Canada, against 57 last year.

The Siamese nobles have asked that the king appoint a crown prince. The eligible son is being educated in England now.
