The Claimant

An illustration of this diversity tween men and animals occurred during the eighteenth century in the case of a young Irishman who emigrated to America and later returned to his native country. Arthur Donovan was a younger son of the Earl of Strongford. Young Donovan was devoted to hunting, and, since there was a fine pack of hounds on the estate, he occupied himself largely with the sport.
