The press announced a few days ago that the minister had met with Canadian shoe manufacturers, especially those of the Eastern Townships and that the latter had brought to his attention the excessive importation of shoes into Canada.

Can the minister indicate whether his department or the government propose to do something to improve this situation?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): Mr. Speaker, we are working with the Quebec Industry and Commerce Department to develop an over-all program that should enable us to approach this question of shoe imports in a similar way to that which was used in the case of textiles and clothing.

Discussions are continuing in that direction and we hope soon to be in a position to make the usual announcements.
