Hon. Otto E. Lang (Minister of Justice): I cannot answer at this stage, Mr. Speaker. We are having discussions with various farm organizations concerning the nature of any questions put, and also the qualifications of voters. There have been suggestions as to two basic types, that it be a vote by rapeseed growers only, on the one hand, or a vote by all permitholders on the other. This is the issue to be resolved.

REASON FOR REDUCTION IN NUMBER OF WOMEN MEMBERS AND THOSE WITH BROADCASTING EXPERIENCE

Mr. J. P. Nowlan (Annapolis Valley): Mr. Speaker, my question is for the Minister of Communications. What was the basis of the criterion that the minister used to reduce from two to one, out of a total of 15, the number of women serving with the CRTC, and to reduce from three to two the number of individuals with broadcasting experience?

Hon. Gérard Pelletier (Minister of Communications): Mr. Speaker, first, I must say that there is constant disruptions in agencies of this kind. We must always attempt to reach the most perfect equilibrium. I would add for the encouragement of the hon. member that vacancies sometimes occur in the CRTC as in other similar agencies. Even if, at times, there seems to be some disruption, the government keeps in mind that it must be remedied as soon as possible.
