contingent were present in California, the figure in (C) above cannot satisfactorily be broken down to reflect the travel itinerary.

- 6. Authority for the payment of transportation expenses was included in the decision of the Treasury Board dated May 12, 1975, which authorized Canadian participation in the Roses and related Bicentennial activities. The type and nature of transportation in the California activities was the result of numerous operational decisions made by officers attached to the Canadian Consulates General in Los Angeles and San Francisco and with the concurrence of the Department of External Affairs in Ottawa. Each decision was based upon the anticipated requirements, the local knowledge of the officers concerned, and the ability of local firms to provide adequate transportation at the times required.

The selection of accommodation for the California activities was the result of numerous operational decisions made by officers attached to the Canadian Consulates General in Los Angeles and San Francisco and with the concurrence of the Department of External Affairs in Ottawa. Each decision was based upon the proximity of the hotels to the performance sites and the ability of the hotels in those areas to provide sufficient space of an acceptable standard.

Hon. Barney Danson (Minister of State for Urban Affairs): For the Canadian Habitat Secretariat 1. The National Committee for Habitat held public meetings in the following centres: Inuvik, Whitehorse, Prince George, Van-

couver, Quebec City, Edmonton, Montreal, Halifax, Fredericton, Toronto, Thunder Bay, Frobisher Bay, St. John's, Winnipeg, Charlottetown, Regina.

- 2. (a) Total fees paid were \$7,400; (b) Total travelling expenses were \$16,200.
- 3. At each meeting the Canadian Habitat Secretariat provided one administrative officer, one program officer, and one information officer to assist and service the members of the National Committee for Habitat. At each meeting, with the exception of Inuvik and Winnipeg, the Secretary of State Official Languages Conference section provided two or three interpreters for English to French and French to English simultaneous interpretation. As the Secretary of State office could not provide interpreters for Inuvik and Winnipeg, the Department of Supplies and Services let contracts to provide for simultaneous interpretation interpreters. At each meeting, the firm of International Translation Services of Toronto provided a technician with simultaneous interpretation equipment. This firm was awarded the contract by DSS.
- 4. Total travelling expenses for Canadian Habitat Secretariat staff, Secretary of State interpreters and public relations people, were \$22,000.
- 5. Organizing expenses, including simultaneous translation, rentals, hospitality and advertising, totalled \$75,000.
- 6. Attendance by the general public at each meeting was as follows: Inuvik, 70; Whitehorse, 35; Prince George, 45; Vancouver, 250; Quebec, 47; Edmonton, 175; Montreal, 135; Halifax, 30; Fredericton, 30; Toronto, 138; Thunder Bay, 50; Frobisher Bay, 100; St. John's, 85; Winnipeg, 110; Charlottetown, 16; Regina, 90.
