Unfortunately, the hon. member has done two things wrong in her motion. First, I think she has picked the wrong government and second, I think she has picked the wrong target, namely the 1992 budget.

I would like to speak for a couple of minutes about some of the elements of the budget, some of the things that it was trying to accomplish and some of the ways that the budget is trying to address some of the concerns that prompted the hon. member in all her sincerity and good intentions to put forward a motion which unfortunately misses the mark.

To start with, it is important to remember that this budget cuts taxes, in fact \$1.2 billion will be the reduction in 1992. Cutting taxes helps reduce or remove partially some of the burden that is placed on Canadian families and that is going to have the net benefit of putting more money into household budgets and helping. A tax cut is better than a tax increase. We have had years of tax increases for many reasonable reasons.

Mr. Speaker wishes me to conclude? I just started, sir. Will I have an opportunity to complete my remarks later?

Mr. Speaker: I wish to say to the hon. member that I apologize for interrupting the hon. member. We have had a message from the Senate and we are obligated to deal with that. The hon. member will I hope be able to continue with his remarks afterward. Again I do apologize.
