## FOLLOWS ST. JOHN'S EXAMPLE

New Westminster Spending Half Million  
For Its Own Wharves

New Westminster, B. C., Dec. 27.—Full  
recognition of the city's possibilities as an  
ocean port is contained in the annual re-  
port of the minister of public works at  
Ottawa. This is how the government de-  
partment summarizes the situation on the  
Fraser river and at New Westminster:—

"The city council of New Westminster,  
on the Fraser river, with praiseworthy ini-  
tiative, have arranged to expend the sum of  
\$500,000 in the construction of wharves  
along the waterfront, and the extending of  
Front street to afford room for trucking  
etc. New Westminster, in providing for  
ocean-going terminals has an immense ad-  
vantage over the cities of Victoria and  
Vancouver, inasmuch as almost the entire  
waterfront is publicly owned. The wharves  
over, the water being fresh, a much cheap-  
er method of wharf construction can be  
used than in either of the other harbors."

tween \$2000 and \$3000. They are asking  
for assistance from the loan fund of the  
Home Mission Board.
