A Sanitary county delegation, composed of Dr. Peake, chairman of the board of health, and Councillors Wilcox and Perley, appeared before the meeting and presented copies of a resolution adopted at the last meeting of the Sanitary County Council, protesting against the proposal to empty the sewage of Fredericton into the St. John river. It was pointed out that residents of the river parishes in Sanitary use river water for domestic purposes, and request that it be kept free from contamination by sewage. A suggestion was made that the board should recommend the government to appoint a commission to investigate the matter. Consideration was postponed.

A delegation from Woodstock Agricultural Society, composed of C. L. Smith, R. E. Holyoke, Robert McQuarrie, and Henderson, waited upon the commissioner of agriculture this evening and asked for a substantial grant to enable Woodstock to hold an exhibition next year. The commissioner assured that the matter would receive the attention of the government. Solicitor-General Jones accompanied the delegation.
