Hon. Donald S. Macdonald (Minister of National Defence): 1, 3 and 4. This information is tabled in the House annually in accordance with Revised Statutes 1966-67, c.44, s.53, and also appears in the Public Accounts, as Appendix 1, to the National Defence Expenditures.

2. Section 21 of the Canadian Forces Superannuation Regulations were amended by TB/CT 692055-1, dated September 25, 1969.
