

**MANPOWER****EMPLOYMENT PLANS FOR THOSE LOSING JOBS AT WINNIPEG AIRCRAFT OVERHAUL BASE**

**Mr. David Orlikow (Winnipeg North):** My question, Mr. Speaker, is directed to the Minister of Supply and Services. In view of the sharp staff reductions at the Winnipeg aircraft overhaul base, and in light of the commitments made earlier to the government of Manitoba and to former employees of Air Canada that the base would continue as a viable operation for a number of years, may I ask whether the department has worked out any plans for further employment for the hundreds who are being dismissed?

**Hon. James Richardson (Minister of Supply and Services):** It is correct, Mr. Speaker, that the United States Air Force intends to phase out the T-39 program. This will be done during the summer months, and there will still be some planes going in as late as September. During this period my department and other departments will be working to find ways to increase the workload.
