## SHORTAGE OF BOXCARS FOR SHIPMENT OF BRITISH COLUMBIA LUMBER

Mr. Frank Howard (Skeena): Mr. Speaker, I wish to direct a supplementary question to the Minister of Transport with regard to the allocation of boxcars. Is the minister aware of the situation in north central British Columbia where there is a shortage of approximately 2,000 boxcars for lumber shipment, the result of which is increasing unemployment in sawmills and the logging section of the industry, all because CNR is unable to supply the required number of boxcars to move the lumber out of that area.

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, the situation is the same for the British Columbia Railway which is owned by the British Columbia government. Because of the strike there are shortages everywhere. Attempts are being made to supply as many boxcars as possible. There is a shortage at the present time. There is no doubt about it.

DEER LODGE HOSPITAL, WINNIPEG—EFFECT OF DELAY IN REACHING WAGE SETTLEMENT WITH NURSES ON CONDITIONS

Mr. Dan McKenzie (Winnipeg South Centre): Mr. Speaker, my question is for the Minister of Veterans Affairs. Due to the government's ten month delay in settling wage negotiations with the nursing group of the Professional Institute of the Public Service, which is causing serious economic problems for the nursing staff at Deer Lodge Veterans Hospital in Winnipeg, plus low morale, staff shortages and, the most serious aspect of the problem, decreasing nursing attention to our veterans in that hospital, will the minister order an investigation and take corrective action on the deplorable conditions which exist at Deer Lodge?
