UIC—PAYMENT OF BENEFITS IN QUEBEC BY PAYMENT CENTRES

Question No. 2,103-Mr. Beaudoin:

- 1. For the Province of Quebec are UIC benefits paid from certain centres and (a) if so, is the Commission the owner (b) if not, (i) who is the owner (ii) at what rent?
- 2. How many employees work in the Payment Centre?
- 3. What is the average processing time for the payment of a benefit?

Hon. Robert K. Andras (Minister of Manpower and Immigration): In so far as the Unemployment Insurance Commission is concerned: 1. There is only one payment centre in the Quebec Region. (a) This centre occupies two floors of the building located at 1441 St-Urbain Street in Montreal. (b) It is a federal building belonging to the Department of Public Works.

- 2. As of April 3, 1975, there were 258 employees working in the payment centre.
- 3. The payment centre's average unit cost for issuing a warrant was \$0.65 in 1974. The average unit cost incurred from January 1975 to March 1975 was \$0.52.

UIC—NUMBERS OF APPEALS SUBMITTED AFTER PRESCRIBED DEADLINES, 1974

Question No. 2,156—Mr. Gauthier (Roberval):

In 1974, how many appeals were submitted to UIC arbitration boards after the prescribed deadlines and, of this number, how many were heard?

Hon. Robert K. Andras (Minister of Manpower and Immigration): No records are maintained but the Commission is usually lenient in accepting appeals filed after the 30 day limit provided by the Unemployment Insurance Act.
