CALL FOR LEGISLATION TO PROTECT HOME OWNERS—MOTION UNDER S.O. 43

THE ECONOMY

SUGGESTED REVIEW BY STANDING COMMITTEE OF INTEREST RATE POLICY—MOTION UNDER S.O. 43

Mr. Don Blenkarn (Mississauga South): Madam Speaker, I rise under the provisions of Standing Order 43. The government's high interest rate policy has resulted in interest rates in Canada 4 to 5 per cent higher than those in the United States. For example, the Bank of Canada rate is 18.95 per cent, the Euro-dollar rate is 14.5 per cent. This government's T-bills are quoted at 18.55 per cent; American T-bills are 13.53 per cent. Banker's acceptance money for 30 days in Canada is quoted at 18.9 per cent; in the United States at 14.35 per cent. First mortgages in the United States are 16 to 16.5 per cent, and Americans deduct the interest from their income taxes. Candians pay 21 per cent and more without relief. I therefore move, seconded by the hon. member for Vancouver Centre (Miss Carney), the same motion moved in a previous session by the hon. member for Windsor West (Mr. Gray):

That this House immediately order its Standing Committee on Finance, Trade and Economic Affairs to undertake an immediate review of the interest rate policy of this government and of the Bank of Canada, and that for this purpose the Governor of the Bank and the Minister of Finance appear before it to explain their actions.
