During the 120-second clip, the phrase "neat to be dead" in one form or another is mentioned 21 times. This is irresponsible broadcasting. Given that 281 young children and teenagers committed suicide in Canada in 1984, this is a serious problem and not a laughing matter. To suggest on prime time radio, or for that matter at any time, that death is neat and a joke is appalling. The CBC should act responsibly by carrying an apology and a retraction on *Frantic Times* indicating that death is not neat nor is it a joke.

CANADIAN RADIO-TELEVISION AND TELECOMMUNICATIONS COMMISSION

CONCENTRATION OF TELEVISION STATIONS' OWNERSHIP IN SASKATCHEWAN

Mr. David Orlikow (Winnipeg North): Mr. Speaker, Saskatchewan has recently seen a dramatic concentration in private television ownership with the acquisition by the John Bassett interests of Toronto of four out of five private television stations. This has been accomplished without any public protest from the Minister of Consumer Affairs (Mr. Côté), or from Conservative Members who have been able to count on Mr. Bassett as an enduring and loyal friend. However, the Canadian Radio-Television and Telecommunications Commission stated in a 1978 ruling that, to the extent that concentration of ownership and control increases, diversity of opinion and information to Canadians are potentially reduced. It is this very real threat, that John Bassett will be presiding over an homogenized private broadcasting system in Saskatchewan, that has many people concerned.

Saskatchewan is only one step from being the media conglomerate that New Brunswick already is and which the Kent Royal Commission on Newspapers attacked for not having "diverse voices, correcting and balancing one another".

The Kent Commission also recommended that Armadale divest itself of one of its two daily newspapers in Regina or Saskatoon. This should also apply to television stations in Regina and Saskatoon, which are among the most profitable in the country, with profit margins of 40 per cent.
