LOANS FOR SEWAGE TREATMENT PROJECTS

Question No. 1,734—**Mr. Herbert:**

By province, since 1974, what amount of loans was approved for sewage treatment projects and, in each case, what is the federal forgiveness of loan principal and/or interest?

Mr. Ralph E. Goodale (Parliamentary Secretary to President of the Privy Council): In so far as the Department of Regional Economic Expansion is concerned: Since 1974, the department has approved loans of \$438,404 (Manitoba) and \$260,565 (Saskatchewan) for sewage treatment projects under the Agricultural Services Centres Programme. The federal forgiveness of loan principal and/or interest in all cases is nil.

In so far as Central Mortgage and Housing Corporation is concerned: See Table 1 following.
