I do not want to take up a great deal of time of the House on this because the ruling is so straightforward and clear, but I think it is important that the hon. member for Calgary Centre understand exactly how the Main Estimates were prepared this year. I would like to give my assurance to him and to you, Madam Speaker, that no matter how much research he conducts he will not find in these Main Estimates any provision which is in conflict with your ruling.

### CO-OPERATIVE ENERGY ACT

MEASURE TO ESTABLISH THE CO-OPERATIVE ENERGY CORPORATION AND THE CO-OPERATIVE ENERGY DEVELOPMENT CORPORATION

Hon. Marc Lalonde (Minister of Energy, Mines and Resources) moved that Bill C-116, to establish the Co-operative Energy Corporation and the Co-operative Energy Development Corporation, be read the second time and referred to the Standing Committee on National Resources and Public Works.

He said: Madam Speaker, Bill C-116, an act to establish the Co-operative Energy Corporation and the Co-operative Energy Development Corporation, is another step toward the achievement of the goals of the National Energy Program. It will enable the Government of Canada to participate in a joint venture with an association of co-operative marketing and financial institutions. It will provide a new source of funds to the petroleum industry, new investment opportunities to individual Canadians and an increase in the share of the oil and gas industry that is owned by Canadians. The joint venture will be called Co-Enerco.

As all members of this House are aware, the capital requirements of the petroleum industry in Canada over the next decade will reach unprecedented levels. The Government of Canada is committed in the National Energy Program, to increasing the share of the industry that is Canadian-owned.

Co-operative organizations, with nine million members and an estimated \$45 billion in assets, represent a significant new source of capital. In the past, co-ops have had little participation in oil and gas investments, although there has been some involvement in refining and sales. With the new financial and fiscal regime introduced in legislation, particularly the petroleum incentives program now before the Senate, and
