PRAYERS.

Pursuant to the Order of the Day the following Petition was read:—

Of *Pierre Cazabou* and others, of the Electoral Division of *Berthier*,—praying that the duty on Canadian Tobacco may be abolished.

The Honorable Mr. *Hamilton (Kingston)*, from the Committee on Banking, Commerce and Railways, to whom was referred the Bill intituled : "An Act to incorporate the *Canada Marine Insurance Company*" reported that they had gone through the said Bill, and had directed him to report the same, with several amendments which he was ready to submit whenever the House would be pleased to receive them.

*Ordered*, That the Report be now received, and  
The said amendments were then read by the Clerk as follow :

Page 2, Line 15. Leave out "Province of *Quebec*" and insert "any Province in *Canada*."

Page 4, Line 20. After "appointed" insert "from time to time by the Board."

Page 5, Line 18. Leave out "and such" and insert "but no stock not fully paid up shall be transferred without the consent of the Board, and"

Page 5, Line 26. Leave out from "Company" to "detailed" in line 29, and insert "at each annual meeting a"

Page 6, Line ult. After "passed" insert "provided always that the Company shall make the deposit required by the fourth section of the said Act by instalments, as in the "said section is provided," the first of which instalments shall be so paid before the issue of "the license required by the said Act."
