

The Selectors are to meet on the first of September in each year (if a dies non, then on the day after, &c., &c.), at the public meeting place of the Municipal Council, or some other place within the Municipality, named by the Head of the Corporation, for the purpose of selecting from the Assessment-Rolls the persons qualified and liable to serve as Jurors.

Each Selector is sworn to an impartial selection by a Justice of the Peace; two-thirds of the qualified persons on the Rolls must be selected. In case of an equality of votes in making any selection, provision is made for a casting, or double vote, being given to the Mayor or Reeve first, Town Clerk second, or Assessor of most numerous Roll, or first Assessor in case of joint Assessors.

Thirdly.—An equal number of ballots, with the number selected, is made out, names of parties selected written thereon, and one-half of the number drawn, and openly declared as each is drawn.

The necessary number being completed, the list is distributed into four divisions: first, as Grand Jurors in Superior Courts; second, as Grand Jurors in Inferior Courts; third, as Petit Jurors in Superior Courts, including Court of Chancery; fourth, Petit Jurors in Inferior Courts. The distribution being in the following proportion for each division: one-twelfth for the first; two-twelfths for the second; three-twelfths for the third; six-twelfths for the fourth, or as nearly as may be.

The Report (as it is called) is then to be made out in duplicate, under the hands and seals of the Acting Selectors, in a form prescribed with a written declaration subscribed, by each Selector, that he has made the selection to the best of his judgment, pursuant to the Act.

One of such duplicate reports is to be filed on or before the 15th September, with the Clerk of the Peace of the County; the other, with the City or Township Clerk. The loss or destruction of one duplicate to be supplied by certified copy of the other.

The Clerk of the Peace of the County is to keep a "Jurors' Book," and transcribe therein, between the 15th September and the 10th November, in alphabetical order, from the report of the Selectors, the names and additions of the persons selected as Grand or Petit Jurors, to be transcribed in four Rolls, according to above distribution.

On or before the 31st December, he is to deposit a certified copy thereof with the Clerk of the Crown and Pleas of the Queen's Bench in the County.

Provision is made for certified copies in cases of loss by fire, and for division of Counties after the selection.

On the first day of the Court of General Quarter Sessions in each County, held after the 10th November, the Clerk of the Peace is to bring into Court, and publicly deliver to the Chairman, *sedentè curiâ*, the Jurors' Book for the then next year, with the Jurors' Books of such preceding years, as may be required, and make oath in open Court, to the best of his knowledge and belief, after comparison, that the Jurors' Rolls contain a correct transcript of the persons selected, balloted and reported; and that the other Jurors' Books are those remaining on file in his office.

The oath is to be modified accordingly when Clerk has been changed, or books brought in for first time, and if there is reason to suspect tampering with the original entries, before coming into the Clerk's possession, in consequence of which he cannot make the oath, the Quarter Sessions is to enquire into the matter.

The Books having been received, the Chairman certifies the same therein under his hand and seal, and minute of the same is made by the proper officer.

The Court then proceeds to consider the probable amount of judicial business for which Jurors will probably be requisite, in order to determine whether to select a full Jury List, or a two-third or half Jury List.

If a full Jury List is determined on, it would be:—
