28 Victoria.

Two Petitions of the Reverend *Thomas W. Mussen* and others, of West *Farnham*; praying for the redress of certain grievances connected with the subject of Protestant Education in *Lower Canada*; and also praying for aid for the *Yamaska* Dispensary.

Of the Municipal Council of the Village of *Chicoutimi*; praying for certain amendments to the Consolidated Municipal Act of *Lower Canada*.

Of Xavier Brassard and others, of the Township of Jonquière, in the County of Chicoutimi; praying that the said Township may be separated from the Township of Chicoutini, and erected into a separate Municipality.

Of the Reverend Jos. Hudon and others, of the Parish of Notre-Dame de Laterrière, in the said County of Chicoutimi; praying for aid for the construction of a Bridge over the River du Moulin.

Of the Reverend A. Chouinard and others, of the Township of St. Denis, in the County of Rimouski; praying for aid for the opening and continuation of certain Colonization Roads in the said Township.

Of the Reverend F. M. Fournier and others, occupants of lots of land in the Township of *Bégon*, in the County of *Témiscouata*; praying for aid for opening and improving certain Roads in the said County.

Of the Canadian Land and Emigration Company; praying for the passing of an Act confirming their Act of Incorporation, and for other purposes.

Of Wm. Taietsiaronsere de Lorimier and others, Indians of Caughnawaga; praying against the amendment of the Act 14 and 15 Vic., Cap. 59.

And of Frances Sylvester and others, widow, creditors and friends of the late Boyd Sylvester; praying for the passing of an Act authorizing the sale of the Estate of the said late Boyd Sylvester.

On motion of the Honorable Mr. Reesor, seconded by the Honorable Mr. Sanborn, it

was

Ordered, That the Honorable Mr. Alexander be added to the Committee on Mining.

Pursuant to the Order of the Day, the House resumed the adjourned Debate on the motion of the Honorable Sir E. P. Taché for an Address to Her Majesty, praying that She may be graciously pleased to cause a measure to be submitted to the Imperial Parliament for the purpose of uniting the Colonies of Canada, Nova Scotia, New Brunswick, Newfoundland, and Prince Edward Island, in one Government, with provisions based on the Resolutions which were adopted at a Conference of Delegates from the said Colonies, held at the City of Quebec, on the 10th of October, 1864.

After further Debate,

On motion of the Honorable Mr. Ross, seconded by the Honorable Mr. Campbell, it was

Ordered, That further Debate on the said motion be postponed until to-morrow.

The Honorable Mr. Ross moved, seconded by the Honorable Mr. Campbell,

That when the House adjourns this day, it do stand adjourned until to-morrow, at three o'clock in the afternoon.

The question of concurrence being put thereon, the same was resolved in the affirmative.
